Thank you for your interest. I appreciate the opportunity to earn your business. Forget about having to choose from a bunch of packages because I don't have picture or time limits. I believe wedding planning is complicated enough already!

I go to the rehearsal if at all possible. This way I get to meet the clergy and get any instructions/rules they might have concerning the ceremony. While I'm there I also shoot candid photos of the rehearsal. I get to see the lighting conditions and I look for nice backgrounds to use for your pictures. I am able to see how the ceremony will go for staging of the shots.

On your special day I shoot a combination of posed portraits and candid/photojournalistic shots to record your wedding. I also use the information I have gotten from you to customize your coverage and the type of photographs you want me to take. Since weddings bring families together, getting those family portraits are not a problem.

During the reception, I take candid shots and catch the action as it unfolds. I take pictures of the guests at their tables. I naturally shoot the usual reception events and I will stay for a period of time to "catch the action" during the general dancing of the evening.

After the wedding, I process the proofs and put the 4x6 proofs on a CD. You choose which photographs from the proofs you want me to retouch and finish. Those pictures are copyright-released, high-resolution and ready for printing! I put those on a DVD. The decision is yours as to who does your printing. I include (4) 8x10 prints and (4) 5x7 prints of your choice in the wedding coverage. If you want additional prints I charge \$5.00 for a 4x6, \$10.00 for a 5x7 and \$20.00 for a 8x10. I also have coffee table books and albums available as well. For 2010 I charge \$1,100.00 to shoot a wedding.

It will usually take me several weeks to process the pictures that you have chosen from the proofs. But I make no apologies. I refuse to do "cookie-cutter" weddings. I want your pictures to be as unique and special as you are. One of the ways that I make them unique is to apply special effects to copies of the original pictures. Special effects are never applied to original pictures.

If you would like me to shoot your wedding and reserve that date for you, I need a signed agreement along with a check for the retainer. The amount of the retainer is \$350.00. The balance needs to be paid 30 days prior to the wedding date.

I believe weddings are a special event. In today's society with the no-strings/attachments mentality it is awesome to see 2 people make a commitment to each other that will last a lifetime. Each time I shoot a wedding I feel honored to witness that commitment and to be able to record it for them so they can view it down through time.
